4. Candidates must possess a valid driver's license. Applicants for Deputy must be licensed in South Carolina. There shall be no suspensions in the prior five years due to a DUI or leaving the scene of an accident.
5. You must have a State High School Diploma or State GED certificate.
6. You must have a satisfactory criminal history check.
